Sales & Operations Planning (S&OP)

What does this involve?

The goal of sales & operations planning is to develop coherent and stable plans with high forecasting quality which are in line with the corporate and financial planning. For this purpose, we assist you in preparing and optimizing the corresponding processes and their support by applying high-performance IT solutions.

How do you benefit from implementation/optimization of the S&OP processes?

Security through minimal planning risk, because reliable forecasts facilitate seamless production planning and implementation. **Upturn in sales**, because out-of-stock situations occur less frequently, therefore reducing lost sales, and as a result, customers boost their order volume. **Upturn in profit** due to lower inventories, fewer errors and lower planning instability in the planning processes.

What approach do we take?

In an **analysis of the as is situation**, we evaluate both quantitative (e.g. forecasting quality) as well as qualitative factors (e.g. forecasting processes). Based on best practices, **binding processes are defined** in coordination with the specialist departments involved. During the implementation phase, we make sure the **new processes are implemented** through employee training programs and monitoring.



Inventory Management

What does this involve?

We advise you regarding the implementation of a systematic inventory management with the goal of achieving high delivery reliability with minimal warehouse stock. We make sure your stock turnover increases, which enables your net current assets to be reduced significantly.

How do you benefit from optimization of working capital management?

Liquidity through release of tied-up capital by means of reduced inventory levels. **Upturn in profit**, e.g. due to lower interest expenses, increase in sales due to enhanced delivery capability, fewer end-of-life articles and less storage capacity requirements. **Fast payback** thanks to the leverage effect of the net working capital: just a moderate reduction in inventory is already enough to cover the cost of a project within a short timeframe.

What approach do we take?

The first steps are to **record and analyze current inventory management processes and inventory structures**. By using benchmarks and checklists, areas with potential for improvement are identified, too. Based on results of the analysis, the **concept for specific improvement measures** is then designed (such as target days' supplies) and an **implementation plan to structure new flows/processes**. During **implementation**, we especially focus on the sustainable reduction of the inventory level as well as regular reporting of the essential key inventory performance indicators.



Inbound & Outbound Logistics

What does this involve?

Make-or-buy decisions are of pivotal importance in the transport and warehouse logistics sector: In many cases, outsourcing can boost the efficiency of logistical activities. With our professional and structured tender, we support you in identifying the right service providers and in improving terms & conditions. Fierce competition in the market for logistics services offers the ideal prerequisites for this.

How do you benefit from improvement of prices and conditions in transportation and logistics?

Upturn in profit thanks to our transportation/logistics tenders, which frequently result in significant savings in a two-digit percentage range. **Flexibility** in a two-fold way:

• Identification of high-performance service providers enables better responsiveness to customers' requests through a redistribution of volumes.

• Thanks to outsourcing, fixed costs are replaced by variable costs. Supply What approach do we take? Chain Our complex transportation and logistics tenders follow a five-staged approach: Configuration with a potential analysis and concept design, savings potential is quantified through benchmarks. Using a supplier self-assessment (RFI = Request for Supply Chain Information), suitable providers are preselected. Afterwards, the tender Organization for transportation and warehouse volume takes place in a qualified group of bidders by using a RFP (= Request of Proposal), followed by final negotiation with the best bidders to clarify the last details (processes, contracts). Supply Chain Reporting & IT

What does this involve?
